- 1 Bidding is open to all Eligible bidders / Firms which are registered with C&W / PP&H department for E-Bidding.
- 2 Prospective bidders are required to get Username and Login detail from IT section, Office of Chief Engineer Buildings/PHE (North) Block N DHQ Muzaffarabad. Bidders / Firms which are already electronically registered with the department can use already provided Username and Login.
- 3 Bidding documents and instruction to bidders can be downloaded up to one day prior to the opening date from PP&H web site (www.cwd.ajk.gov.pk).

- 4 Bidders who submitted their financial bids without a valid call deposit will be debarred from participating in bidding process for one year.
- 5 The Bid Securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of Validity of Bid, whichever is earlier.
- 6 Electronic bidding shall be done on **Percentage (above/below) basis On Market & Prevailing MRS, 2nd BI-ANNUAL-2024 (01.07.2024 to 31.12.2024) DISTRICT RAWALPINDI**” Only two digits after the decimal point shall be considered for evaluation purpose.
- 7 “Black listed Firms / Companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation” and all bidders shall furnish an affidavit /certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
- 8 The bidders are required to submit their Electronic Bid on 26-12-2024, **12:00 PM**. Bid will be open by the bid opening committee at **12:00 PM** on the same day in the presence of bidders or their representatives who choose to attend. All other term & conditions are available in bidding documents.
- 9 Electronic bids will be displayed through online E-Bidding system after closing time in the presence of bidders / their representative who choose to be present.
- 10 Any bidder (s) which provides incorrect information shall stand disqualified as per PPRA Rules.
- 11 The competent authority in accordance with PPRA Rule 33 reserves the right to reject all Bids proposal at any time prior to the acceptance of bid or proposal.
