The Executive Engineer PWD Buildings Division Rawalakot on behalf of the Employer invites sealed bids in accordance with AJK PPRA rules 36 (a) Single Stage Single Envelope bidding procedure from eligible firms/Contractors licensed by Pakistan Engineering Council for the year 2022-23 & endorsed by PWD AJK in appropriate category with relevant specialization codes for the following works. Foreign bidder is entitled to participate in bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provision of PEC bye-laws. Bidders desirous to bid as joint venture must get prior approval of the employer for bidding as joint venture.

Bidding is open to all eligible Bidders

- 1 Bidding is open to all Eligible bidders / Firms which are registered with C&W / PP&H department for E-Bidding.
- 2 Prospective bidders are required to get Username and Login detail from IT section, Office of Chief engineer Buildings/PHE (North) Block N DHQ Muzaffarabad and may get necessary training about the bidding procedure. Bidders / Firms which are already electronically registered with the department can use already provided Username and Login.
- 3 Bidding documents and instruction to bidders are available on dash board of E-Registered bidders / Firms on website ([Http://cwg.tenders.ajk.gov.pk](http://cwg.tenders.ajk.gov.pk)).
- 4 The bidders must have to upload the scanned copy of call deposit issued from any scheduled bank of Pakistan having its branches in Azad Kashmir or Bank of AJK before uploading of their financial bid. The same must be provided in original alongwith signed and stamped bidding documents & bidder profile within two days after opening of tender on the address of the Employer.
- 5 Bidding documents are available on the dash board of E-registered Contractors/ Firms.
- 6 All the bidders must have to submitted the documents mentioned at serial # 4 above alongwith valid /original CDR , who do not submit signed and stamped bidding documents/ profile alongwith valid CDR, will be debarred from participating in bidding process for one year.
- 7 The Bid Securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of Validity of Bid, whichever is earlier.
- 8 Electronic bidding shall be done on **Percentage (above/below) basis On Market & Prevailing AJK-CSR April-June 2020-21 Upto December 2022 District Poonch**” bidders have to code Only two digits after the decimal point.
- 9 The bidders are required to submit their Electronic Bid on **03-05-2023 at 11:30 AM**. Which will be open by the E-Tendering system and comparative statement will be visible to the participants bidders and bid opening committee after **12:00 PM** on the same day. Bidders may also watch the bid opening activity online on their dash board instead of their presence in person at any venue.
- 10 The competent authority in accordance with PPRA Rule -33 reserves the right to reject all Bids proposal at any time prior to the acceptance of bid or proposal.
