The tender notice issued from this office vide no 1616-24 dated 10-04-2023 & Corrigendum no 1809-16 dated 29-04-2023 which was published on AJK PPRA website no 4778 dated 11-04-2023 below amendment has been made. (NIT conditions ( i-viii) is replaced with new below conditions (1 -14).

1. Bidding is open to all Eligible Bidders / Firms which are registered with C&W department for e-bidding.
2. The Executive Engineer Highways Division Rawalakot on behalf of the Employer, invites sealed bids under **AJKPPRA Rules 36(b) Single Stage-Two Envelope Procedure**, from eligible firms or contractors licensed by the Pakistan Engineering Council (PEC) for the year 2022-23 and duly endorsed by Chief Engineer Highways North/South Public Works Department AJK in the appropriate category with field of specialization as mentioned in column No.4 for the above work(s).
3. Prospective bidders are required to get Username and Login details from IT section, Office of Chief Engineer Highways (North), Block H, DHQ Muzaffarabad. Bidders / Firms which are already electronically registered with the department can use already provided Username and Login.
4. Bidding documents and instruction to bidders can be downloaded up to one day prior to the opening date from C&W web site ([www.cwd.ajk.gov.pk](http://www.cwd.ajk.gov.pk))
5. Last date & time for submission of financial & technical bid through e-bidding system will be 23/05/2023 up to 11:30am. Technical bids will be open at 12:00 Pm on same day.
6. Original bid security must be reached in the office of the Executive Engineer PWD Highways Division Rawalakot within 48 hours after opening of bid (Technical Bid) through E-bidding system.
7. Bidders who submitted their financial /Technical bids without a valid call deposit will be debarred from participating in the bidding process for one year.
8. The Bid Securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of Validity of Bid, whichever is earlier.
9. Electronic bidding shall be done on **Percentage (above/below) basis** on Only two digits after the decimal point shall be considered for evaluation purpose.
10. "Blacklisted Firms / Companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation" and all bidders shall furnish an affidavit / certificate that they are neither blacklisted nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
11. Hard Copy of the technical bid must be submitted in the office of the executive Engineer PWD Highways Division Rawalakot within 48 hours after opening of technical bid through E-bidding system. Interested bidders may also obtain a hard copy of bidding document from office of the Executive Engineer PWD Highways Division Rawalakot (Technical Bid Only)
12. Electronic bids will be displayed through an online e-bidding system after 30 minutes of closing time in the presence of bidders / their representative who choose to be present.
13. Any bidder (s) which provides incorrect information shall stand disqualified as per PPRA Rules.
14. The competent authority reserves the right to reject all the bids or any bid under Clause 33 of AJK PPRA Rules.
